**PARTICIPATION AGREEMENT**

I, \_\_\_\_\_ (Sailor's Name), a member of a High School Sailing Team and \_\_\_\_\_ (Parent/Guardian's Name) agree to the terms and conditions of this agreement for the purpose of practice and training at the Youth Sailing Virginia (YSV). The term of this agreement shall be for one year. I/we agree to provide to YSV an Individual Release Form, acknowledging the dangers of sailing and the related activities of the High School Sailing Program, executed by the student sailors and their parent or guardian prior to entering into any activity of the YSV or using the YSV property connected with the YSV High School Sailing Program.

I/we understand that an adult chaperone or coach representing \_\_\_\_\_ Sailing Team shall be on site at each practice and he/she alone shall be responsible for the health, safety and conduct of their team members.

I/we agree to provide a Medical Release to be used in the event of a medical emergency. This medical release is to be kept available on site by the coach or chaperone of my Sailor's Team.

I/we agree to reimburse YSV for any damages caused to YSV leased or owned property in connection with the YSV High School Sailing Program in excess of \$50.00 each occurrence.

The above named student sailor agrees to abide by all *his/her* school policies as interpreted by the coach. Failure to do so will result in immediate dismissal from the team and exclusion from practicing and competing.

The above named student agrees to keep YSV grounds and buildings clean. Furthermore, at the conclusion of the program, agrees to help his/her teammates clean and wax each boat used during training.

Further, access to and training at YSV shall not be granted until this agreement has been fully executed and all terms and conditions of this agreement are met by all parties.
